MANAGEMENT INFORMATION SYSTEM (MIS) The University has three different standalone MIS, all of which provide the information requirement of the management: 1. The Office Automation System wherein all the service registers of the employees of the University are digitized and through the secured entry page the concerned authorities can login to get the entire details of the employees of the University. To ensure the robustness of the system it has been envisaged to scan the physical records and make it part of this system. 2. The second MIS is Biometric Attendance Management System (BAMS). It was an effort to move from the conventional paperbased attendance to embrace the digital attendance system. The BAMS, a software developed inhouse integrates the database of the Biometric Server to the website of the University. The system allows the Heads of Departments / Section heads to make leave entries, monitor and generate reports for various attendance shortcomings like "Not Reported", "Single Punch" and "Hour Deficiency" at their biometric login. Further, shifts for the staff can be pinned to calculate the working hours. The user can view his / her report and can sort out discrepancies in his / her leave entries and other related issues. The leaves are calculated with an opening balance fixed at the beginning of the calendar year. With respect to Earned Leave, the annually availed days are calculated for that particular year since there is nonavailability of cumulative opening balance. Efforts are underway to incorporate the opening balance of the earned leave so that the employees can access and able to find the total earned leave at their credit. 3. The third MIS, Centralized Accounting System simplifies the accounting system and can able to provide the approval at various levels. It encompasses 8 major accounts comprising of 3200 budget heads for various accounts. The Institutionalgrants and projects are individually treated as a separate

major head with project specific budget heads and there are 65 such project accounts. The procedure provides approval at 4 stages, the first stage being the user department or section creating the required file, followed by the Finance section making appropriate entries. In the second stage the approval is given by the Finance Officer, the third stage is approval by the Registrar and the last stage is approval by the Vice Chancellor. If the sanctioned amount is less than Rs. 5000/ the process gets over at the second stage whereas if the amount is less than Rs. 50,000/ it stops at the third stage. If the sanctioned amount is more than Rs. 50,000/ it passes through all the stages. Once the approval is given, an voucher is created for processing the payment. The major advantage of this system is that no wrong entries are made in the budget allocated and ease of transparent accounting. This system of accounting is foolproof and human error is eliminated.

1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained

The institution periodically evaluates the curricular aspects by way of getting feedback from all stakeholders' sources through University's feedback blog to ensure the academic excellence, infrastructure enrichment and harmony in the teaching learning. Responses of students and teachers obtained in their respective portals at the end of each semester used to understand the pulses of students and teachers pertaining to the depth of course objectives and modules, inclusiveness of both basic and current trends in the course content, relevance of reference materials recommended, scope for selection of optional/electives/value-added courses, extent of orientation towards soft skills, project/dissertation/in-plant training/industrial visit/field visit and employable skills. Further, the feedback system available in student portal on teacher competency level, accentuate the subject knowledge of the teacher, teaching skill, interactive teaching, use of appropriate examples, illustrations, special care for weak students, supply of reading materials, use of audio-visual aids etc. The feedback from alumni, industrial stakeholders and other relevant statuary bodies are obtained from time to time. In addition to online feedback system, the Departments receive suggestions from Alumni during the annual Alumni Meet. The University placement cell gets feedback from industry, R D establishments and professionals during campus placement programmes. The Head of the Department receives the feedbacks from Annamalai Biometric Centre (ABC) and other sources and discuss in the staff meeting. The suggestions are placed before the Academic Audit Committee and boards of studies for discussion and for designing curriculum that really engage them. At University level, an Academic Director is overseeing the activity to identify and evaluate the strength and weakness to improve University policy to ensure continual improvement in teaching and learning process and for providing quality education to the students. The feedback system sustains the healthy relationship between students and teachers. Students' demands regarding syllabus are immediately taken into account and catered to meet their growing academic needs. The syllabus is restructured or reframed based on the feedback of students. The feedback system plays a decisive role in bringing out a pragmatic outlook among teachers. Teachers are immensely benefitted by acknowledging the academic aspirations of the younger generation. The feedback facilitates an introspective academic routine reinforcing the need of updating among the teachers of the Department. Parent's feedback also obtained physically whenever they visit the Departments. Above all, the feedback system channelizes both the philosophical and pragmatic visions of the teachers to cater to the academic quest of student community.

The mentoring of students and their welfare is a major priority of the University. Mentoring is a process for developing personal and professional aspects of students through sharing of knowledge, expertise and experience. While all faculties in the university are potential academic advisors to all the students, each faculty is assigned as a Mentor to a small group of students (mentee). The students are mentored from the time of admission to completion of their degree programme. Mentor – Mentee ratio of about 1:5 to 1:15 is maintained in almost all the departments. The Mentor-Mentee system fosters a close and constructive professional relationship between students and the staff of the faculty. Mentors meet the assigned mentees periodically to guide them with their curriculum, monitor their progress, provide intellectual training, help them in making appropriate choices in choosing their optional and add-on courses. Further, mentors help the mentees in applying for scholarships and provide career counseling. Feedback and opportunities for reflective review will be documented after every meeting and the reports filed. Further, our faculties regularly guide the students regarding the rules and regulations which have been followed in the University / Department.

Infrastructure Maintenance: The University Works Division under Director, Estate Development maintains allcivil, electrical, water supply, public health and vehicle maintenance. Manufacturing Engineering workshop takes care of maintenance and refurbishment of furniture. Upkeep of 18 Hostels is governed by the Warden's Council. The University Auto Garage is taking care of maintenance of vehicles. Twenty gardens in the campus are maintained by 75 gardeners supervised by horticulturists. Auditoriums and seminar halls are utilized after getting permission from the Registrar. Library: Sir C.P. Ramaswami Aiyar Library takes care of core library activities viz. Book and journal Acquisition, Registration of new members, Nil Arrear Issue, renewal of membership card records and file-statistics. Most of these functions are automated with barcode system. On-Line Public Access Catalogue is functioning. Annual and life subscription of e-resources are available. Libraries at Faculty and Department levels offer access to specific subject books, and are maintained by librarians. The Libraries are open on all days except public holidays from 8.00A.M. to 8.00 P.M. For unforeseen repairs, university has allocated budgetary provisions for the departments. Equipment found beyond repair is condemned after the approval of technical committee and the Syndicate. Fire safety is implemented in the labs. Students use downloadable requisition forms for utilizing analytical services in Centralized Instrumentation Service Laboratory. Automatic weather station of IMD connected with INSAT 3B is maintained by the university. Orchard, experimental farm and Animal Husbandry unit are maintained by farm managers, gardeners and farm workers. Computers and website maintenance: Informatics center carry out multipronged operations through four strategic units viz., Web Design, Computer Network, Biometric and Computer Service. It has a hardware laboratory with technical experts to maintain hardware. AMC facilitates maintenance of electronic gadgets. The Campus Network Centre ensures seamless connectivity

through wired and wireless network and networking of the CCTV Surveillance cameras to render a secured campus. Animal House and Museums: The Central Animal House comes under the purview of Institutional Animal Ethics Committee formed by CPCSEA, Govt. of India, for approval and supervision of experiments on laboratory animals. Research scholars carrying out animal experiments submit their proposal and maintenance record in downloadable Form B and D to IAEC.

Museums in Agriculture, Entomology (housing more than 50000 rare insect specimens), Earth sciences and Marine biology are open to the public free of cost. Sports Complex: Central sports complex equipped with indoor stadium, Hi-Tech Gymnasium and Athletic track are accessible to students, staff and public.

For facilities like indoor stadium and tennis courts with flood light provision, the access is offered on payment basis for public. University Guest House: Rooms available in the University guest house rented on payment basis after getting permission from the Registrar. Cooperative stores governed by elected office bearers cater to the day -to -day needs of the staff and students.

6.1 - Institutional Vision and Leadership

6.1.1 – Mention two practices of decentralization and participative management during the last year (maximum 500 words)

Decentralization of Research Development Activities of grants section have been decentralized into two entities viz., Centre for Research Development and Grants Utilization Coordination Committee for the effective management of research and development grant. DRD takes care of both government and private funded research grants and consultancy projects sanctioned to the individual faculties. It is headed by a Director, Research Development, who takes care of the speedy processing of each activity such as Research Proposal forwarding to the agency, issue of administrative sanction for received grants, advance sanction, settlement of advances, issue of statement of expenditure, utilization certificate, Project implementation, Grant Utilization, Conduct of Seminars/Symposia, Purchase of Equipment, other items and minor infrastructure augmentation. GUCC takes care of government funded Institutional research, infrastructure grants like RUSA and department level projects such as DST PURSE, UGC- SAP, DST- FIST etc.,. This enables seamless execution of high value infrastructure and research projects under the guidance of a Co-ordinator. These entities ensure timely submission of technical reports, utilization certificates and audit reports to the funding agencies. to fasten the mandatory financial procedures done through PFMS and GeM portals, a separate Co-ordinator has been appointed. To fast track purchase PFMS Co-ordinator is authorized to effect purchase through GeM Portal. Activities related to IPR are taken care by a separate Centre for Intellectual Property Rights. Committees to entail participative management in task oriented activities Various committees at University level and Faculty level are constituted every year to decentralize the powers to enact and speed up the process of completing task oriented academic and administrative works. Committees constituted during the academic year for various tasks include, curriculum revision committees at department and faculty level, admission committee, committee for admission counselling process, student disciplinary action committee, committees for conduct of university functions including Convocation etc. have brought in positive energy to complete the tasks assigned. The ideology of participative management has evinced successful results in task oriented academic processes including preparation of SSR/reports for AICTE, NBA, PCI, NCTE, ICAR, MCI accreditation/approval process and preparatory works related to peer team/inspection team visit. The IQAC has constituted seven criterion teams and faculty coordinators to bring more stakeholders take part in the process of quality assessment and fine tune the documentation works related to SSR submission. Similar committees in faculty of Agriculture, Engineering Technology, Medicine and Dentistry have greatly contributed for successful completion of mandatory accreditation/ approval process pertaining to these faculties. For successful conduct of student events/functions the students are involved to manage various tasks to imbibe leadership quality among students. Involvement of students as managers brought in great success of conducting many events and set example for the success of participative management involving beneficiary stakeholders. Students, Alumni and Industry representations in Board of Studies and IQAC committee meetings, provide scope for greater participative management, which yielded success in all spheres. Curriculum Development	Periodical revision of the syllabi has been in practice. The Boards of Studies include external and internal experts, representatives of stakeholders (alumni, employers and student invitees). Finally the curriculum is placed for the approval of Faculty board and Academic Council. Outcome Based Curriculum is developed to create positive changes in the educational system. Course Outcomes are mapped with Programme Outcomes and Programme Specific Outcomes. The guidelines of national and state level academic and regulatory bodies (UGC, TANSCHE, ICAR, MCI, DCI, PCI, NCI, NBA and AICTE) are taken into consideration in curriculum development. Value Added Courses and Experiential learning are included in the curriculum every year wherever possible with special attention. New courses are introduced to suit employment and entrepreneurial needs. Provision has been made to accommodate current developments in all the courses. Students are given flexibility to select elective courses across various programmes of the university. In each course, the last unit includes the current trends in the
Toughing and Learning	course.
Teaching and Learning	Integration of conventional and modern methods of teaching are encouraged by providing infrastructural facilities and IT tools. Students are exposed to experiential learning through hands-on training, Industrial tie-ups, Field Projects, Internships and Industrial Visits. Initiatives have been made to offer effective online classes through Microsoft Team platform during extraordinary situations as experienced this year due to Covid 19. Feedback from students about the curriculum and teachers are collected every semester and they are shared with the course teachers and heads of departments for further action. Necessary suggestions are given by the authorities and heads. Provisions are

in place for periodical interactions with experts in academics and industries. Slow learners and advanced learners are identified to devise appropriate strategies to augment their learning. Examination and Evaluation The entire process related to examination from registration, fee payment, generation of hall tickets and publication of results has been made online. Examination related information is disseminated through university website, emails, group whatsapp and SMS. Accuracy in the process of evaluation is assured through Double Valuation/Revaluation and Re-totalling. To minimize data entry errors and hasten the process of result declaration the entry of theory marks by examiner is done through OMR coding sheets. The data are processed by our indigenously developed software and the result publication is done online. Question paper setters are asked to set question papers adopting Bloom's taxonomy in encrypted file format and sent to a highly secured confidential email. Online tracking provision helps Ph. D. scholars to track the status of thesis evaluation process. As per UGC guidelines, facilities and protocols are made to conduct of Ph.D. Public Viva-Voce Examination through online platform. RD activities are decentralized to Research and Development two entities viz., Directorate of Research Development (DRD) and Grants Utilization Coordination Committee (GUCC). DRD takes care of research projects of the individual faculties. It is a point source that takes care of speedy processing of research activities such as Research Proposal Submission, Project implementation, Grant Utilization, Conduct of Seminars/Symposia, Purchase of Equipment and minor infrastructure augmentation. GUCC takes care of government funded Institutional research, infrastructure grants and department level institutional projects such as RUSA, DST PURSE, UGC- SAP, DST-FIST etc., received by the University. To coordinate activities related to IPR a Centre for Intellectual Property Rights is function as a separate

entity. Academic Research programmes

such as M. Phil. and Ph.D. are monitored by CARE (Centre for Academic research). Library, ICT and Physical Adequate annual budgetary allocation Infrastructure / Instrumentation for infrastructure augmentation (2.735 Cr.) is offered from general funds. The University has bagged 50 Cr. rupees funding from Rashtriya Uchchatar Shiksha Abhiyan phase-2 (RUSA) to utilize for research and creation of infrastructure facilities, class rooms, etc. Apart from this, the institutional funding from Government of India through PURSE, SAP and FIST projects give sustainable support to maintain the laboratories and to purchase more than 60 major equipment including MRI and CT Scans (14.58 Cr. rupees). Further, the alumni of the university have contributed to asset creation in the university (to the tune of 21. 20 lakh rupees) in various forms to create university infrastructure. Duties and responsibilities are Human Resource Management earmarked for all the teaching and nonteaching staff members of the Department and their activities are monitored. The faculty members are facilitated to attend seminars, conferences, symposia, workshops, refresher, orientation, and short term programmes in order to update and equip themselves with the latest trends in teaching - learning and research. During 2019-20 two FDP programmes were organised for the benefit of the teachers and more than 90 programmes have been organised for the students. Both faculty and administrative staff are encouraged to undergo yoga and meditation programmes to enhance their physical and mental agility. 	different standalone MIS to cater to

the information requirement of the management. First and foremost is the Office Automation System wherein all the service registers of the employees of the university are digitally entered, and through the secured entry page the concerned authorities may login to get the entire details of the employees of the University. To ensure the robustness of the system it has been envisaged to scan the physical records and make it part of this system. The Biometric Attendance Management System is an effort to move from the conventional paper-based attendance to

Administration

embrace the digital attendance system. The AIC BAMS, in-house developed software, integrates the database of the Biometric Server to the website of the University. The system allows the Heads of Departments /Sections to make leave entries, monitor and generate reports for various attendance shortcomings like not reported, single punch and hour deficiency at their biometric login. Further, shifts for the staff can be pinned to calculate the working hours. The user can view their report and can sort out discrepancies in their leave entries and other related issues. The leaves are calculated with an opening balance fixed at the beginning of the calendar year. In respect of earned leave, the annual availed days are calculated for that particular year since there is nonavailability of the cumulative opening balance. Efforts are underway to incorporate the opening balance of the earned leave so that the total earned leave at the credit of all employees can be viewed by the authorities and the individual ca access to his/ her earned leave.

Finance and Accounts

Centralized Accounting System simplifies the accounting system and provides approval at various levels. It encompasses 8 major accounts comprising of 3200 budget heads for regular accounts. The grants and projects are individually treated as a separate major head with project specific budget heads and there are 65 such project accounts. The procedure for approval is in four stages, the first stage being the user department or section creating

the requirement file, followed by the Finance section making appropriate entries. In the second stage the approval is given by the Finance Officer, the third stage is approval by the Registrar and the last stage is approval by the Vice- Chancellor. If the sanction amount is less than Rs. 5000/- the process gets over at second stage and if the amount is less than Rs. 50,000/- it stops at the third stage, if it is more than Rs. 50,000/it goes through all four stages. Once the approval is given a voucher is created for processing the payment. The major advantage of this system is that no wrong entries are made in the budget allocated and ease of accounting. Student Admission and Support Student admission start with online applications to all the Programmes offered by the University. Web-based counselling for all the Professional Programmes are in place. All payments like the tuition fees, examination fees and hostel fees are made online by the students. Students Attendance and Internal Assessment Marks are accessible through Student Portal. Wifi Facilities have been provided to all the 19 Hostels. Biometric Attendance System for the residents of the woman students in the Ladies Hostel with the help of 16 Machines. Online learning resources and e-contents are provided through student portal. Microsoft Team platform is made available for teachers and students to offer effective online classes. The Central Library is kept open seven days a week between 9 a.m. and 10 p.m. to facilitate the students learning in the evening and week end holidays. The students can register for Examination examination, payment of examination fees, generation of hall tickets, issue of hall tickets and publication of results are completely online which the students feel easy. Dissemination of examination related information through emails and SMS. Transparency in the process of evaluation is assured through double valuation/revaluation and re-totalling. As per UGC guidelines facilities and protocols are made available to conduct Ph.D. Public Viva-Voce Examination through online platform.

6.4 - Financial Management and Resource Mobilization

6.4.1 – Institution conducts internal and external financial audits regularly (with in 100 words each)

The institutional accounts are subjected to regular internal and external statutory audits. After internal scrutiny of the bills and vouchers are forwarded by the concerned section to the Government appointed Finance Officer who scrutinise and approve the bills and recommends then to the Authorities for payment. The Public Financial Management System (PFMS) is in effective functioning to manage and oversee the financial practices pertaining to Govt. funds. The major policy and administrative decisions which involve monitory transactions are scrutinised by the Finance Committee before sending for the approval of the Syndicate. The expenditure incurred for State and Central Government funds are audited by Local Fund Audit and then by AG audit as a regular auditing procedure. Annual joint sitting with statutory auditing bodies are arranged to set right the audit objections. The expenditures on private funds are audited by empanelled private auditors recognised by the university. The University appointed a professional auditor who regularly makes checks and balances and also submit the returns to the IT Department. The audited statement of accounts for Govt. And private funding are certified by the auditor.

7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

Logistics using Bicycles: Annamalai University is one of the largest residential Universities in India. Its infrastructure spread around 4 km2 area, accommodating class rooms, offices, staff quarters, hostels, hospital, agricultural field and library close to each other so that the need of motorised transport is kept minimum. Most of the teachers and students who stay near to the University prefer walking instead of using any kind of vehicles. This is a regular scene with most of the members to contribute positively towards the environment. This mode is environment friendly and helps in preventing pollution too. The students who stay in different hostels prefer bicycles as a mode of transport. In the University campus, around 4000 bicycles are regularly used by our students and staff members. Public Transport: The other students who stay in nearby rural areas prefer to use state transport buses as it offers them a concessional monthly pass. It is economically beneficial to students hailing from poor financial status. Plastic-free campus: The University provides resources and tools to educate students on the environmental and health benefits of plastic-free campus to minimize plastic consumption and pollution in the premises and the surrounding environment. Paperless office: The University encourages lesser usage of papers in the office. Similarly, faculty are also motivated to distribute soft copies of class notes to the students. Electronic means such as Gmail or slide share are used for this to share the contents. Whatsapp groups are created class-wise and department-wise to communicate important messages to the students and faculty. Green landscaping with trees and plants: The University maintains more than 20 gardens inside its premises. The University is committed to protecting the environmental heritage of its campuses and has adopted agroforestry for conservation of biodiversity to preserve the natural ecosystems and habitat of

existing species in the campus. Walkways and Pedestrian Friendly Roads: The campus areas have been designed with the concept of open spaces including roads, jogging trails, and lawns. The natural landscape has been preserved while accommodating the demand to use these venues for various purposes Annual Clearance of Invasive Alien Weeds: As a measure to protect ecosystem of the campus, the University is keen in eradicating invasive alien plants like Prosophis and Water Hyacinth every year. It is the vital measure done to prevent conversion of campus land and water bodies to marginal condition. Further, the native plants like Lotus, Neem, etc. which are ideal for conservation are introduced and preserved. All water bodies and campus including two larger ponds (Eratai Kulam) supplying water are desilted and maintained to increase ground water sources. Agriculture Campus periodically maintained all water harvesting structures.

The Context: Annamalai University is set in a rural environ, amidst three most disadvantaged districts of Tamil Nadu where the people are deprived of many livelihood advantages due to marginalized socio-economic and geographic resources. These factors led to increased dependency on Government welfare schemes or Corporate Social Responsibility activities that solace social problems. Being a multifaceted unitary campus with massive student strength, enormous pool of scientific expertise and technocrats the University fulfils the societal needs by providing technical expertise based outreach services in various sectors including health, environment, agriculture and fisheries. Mammoth physical infra make the University a connecting point for district administration and NGOs for successful societal outreach. Annamalai University through such outreach programmes proved that universities need to reach out of lofty ideals of education to serving humanity. Health ? RMMC Hospital with1400 beds, 17 Operation Theatres and all diagnostic facilities serve the patients with free treatment and free diet and provides rest rooms for the relatives of inpatients at a nominal rate of Re.1/- for night stay. The rural health centre in Porto-novo serves the villages near seashore. ? The community medical practices like, dental camp, eye check-up, illness identification camps and special camps during flood in rural households and schools organised by medical students saved many lives in this district. ? The Yoga Centre is offering many yoga programmes and Yoga Therapy? The University offers free access to children, parents and elders to a spacious and well-maintained pollution-free Children's Park, walking corridors and University Pavilion ? The sports complex offers sports/games coaching camps during summer holidays ? As a multi-disciplinary university, it has been imparting knowledge through varied streams of higher education.
