## MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (the “**MoU**”) is entered on  
**19<sup>th</sup> October 2020.**

### BY AND BETWEEN

**Consortium for Technical Education (CTE)**, a trust duly registered under the provisions of the Indian Income Tax Act, 1961, having its office at ‘AMARA SRI’, NEW NO.455, BLOCK NO.75, 7<sup>th</sup> floor, Anna Salai, Teynampet, Chennai-600018, Represented by **Mr Sairaman Srinivasan**, Chief Strategy Officer of the Trust, (hereinafter called ‘the First Party’ which expression shall where the context so admits include its successors in interest and permitted assigns) of the one part;

### AND

**Annamalai University, Annamalai Nagar, Chidambaram** Represented by **Honorable Registrar i/c Prof. Dr. R. Gnanadevan**, (hereinafter called “the Second Party”, which expression shall where the context so admits include its successors in interest and permitted assigns) of the other part.

The First Party and the Second Party are individually referred to as “**Party**” and collectively as “**Parties**”.

**WHEREAS**, the First Party is a Non-Profit Organization that wishes to serve the technical education sector through its innovative progress and services and mend the gap that exists between the academia and technical industry. It also works in the progress and believes that their students’ needs more exposure to new technologies and lateral thinking to give them an edge in this challenging world.

**WHEREAS**, the Second Party is a **Annamalai University, Annamalai Nagar, Chidambaram** is offering a wide range of undergraduate, postgraduate and doctoral programs in 49 departments of study of 10 Faculties. Annamalai University, accredited

with 'A' Grade by NAAC in 2014, is one of India's largest public residential universities. **Annamalai University, Annamalai Nagar, Chidambaram** is placed in the band 101 - 150 in the University Category by MHRD.

**WHEREAS**, the First Party and the Second Party intend to work together whereby

**WHEREAS**, the terms "we," "us," refers to the Second Party, in the applicable Service Terms.

**WHEREAS**, the Parties hereto are desirous of entering into collaboration between them, on the grounds and on the terms and conditions mentioned herein:

**NOW, THEREFORE, THIS MoU WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

**1. OBJECTIVES OF THE MEMORANDUM**

- a. To establish a relationship by which the First Party and the Second Party work in collaboration for the benefit of students education and research purpose and set out the terms of this relationship;
- b. To set out the rights, duties and liabilities of the Parties arising as a result of this MoU;
- c. To establish and set limits to mutual collaboration between the Parties hereto.

**THIS AGREEMENT CONTAINS THE TERMS AND CONDITIONS THAT GOVERNS THIS AGREEMENT AND BOTH PARTIES AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT.**

**2. TERM**

The MoU will commence on the effective date and shall continue to be in force for a period of three (3) years or unless terminated in accordance with the terms of this MoU.

**3. BINDING NATURE**

This MoU between the Parties is legally binding and enforceable. The Parties understand the terms and conditions set forth herein and have consented voluntarily to be mutually bound by the rights, duties and obligations herein.

#### **4. THE SCOPE OF MEMORANDUM OF UNDERSTANDING**

Obligations of both parties:-

- a. The First Party shall arrange Internship program to the students and faculty development programs for the staffs.
- b. The procedural aspects and responsibilities of the collaboration will be based on mutually agreed terms on a case to case basis. A committee shall be constituted with the faculty members of Second Party and representatives of the First Party.
- c. The First Party shall identify industry requirements and will conduct Seminars and workshops.
- d. The First Party shall publish papers on technologies in CTE e- Magazine, conducting Seminars, conduct evaluation and pilot programs.
- e. The First Party shall create Incubation centre and Centre of Excellence in the University campus.
- f. The Second Party will coordinate & invite Research Scholars, faculties and students for publishing technical papers in CTE E-magazine and also participate in software evaluation process. The Second Party will provide work space, electricity, AC, networking, access to internet for incubation centre, Centre of Excellence and for conducting Seminars and Workshops.
- g. Both the Parties shall also mutually work on the research projects.

#### **5. STANDING COMMITTEE**

To facilitate the implementation of this agreement, each party shall designate one or more liaison officers to serve on a standing committee. The standing committee will meet as and when required by giving prior notice to the committee Members. The standing committee would review each party's participation in this agreement, assess the effectiveness of the agreement and identify modifications that might be necessary. The committee would as appropriate address urgent issues and specific cases of non-compliance.

**7. REPRESENTATIONS AND WARRANTIES**

Both the Parties represent and warrant that-

- a. They are duly organized and incorporated under the laws of their jurisdiction, and are empowered to execute, deliver and perform this MoU;
- b. The First Party represents that he/she is a person eligible to contract under Section 11 of the Indian Contract Act, 1872, and that he/she is not disqualified from entering into a contract by any other law prevalent.
- c. This MoU so entered into by the parties does not establish any breach or violation howsoever of any MoU, arrangement or understanding, oral or written, entered



with any other party that would adversely affect either Party's ability to execute this MoU entered upon hereby; ~~\_\_\_\_\_~~

- d. They undertake not to do or cause to be done any act or thing which would result in any representation or warranty contained herein being rendered completely or partially untrue or incorrect;
- e. That the performance of their obligations under this MoU will not violate or infringe upon the rights of any other party or violate any MoU between the Parties and any other person, firm or organization or any law or governmental regulation.
- f. That the First Party, shall not conduct themselves in a manner that would; impair or be detrimental to the rights of the Second Party or any of its representatives, brand name etc; damage the reputation of the Second Party its' brand name or platform, etc.

## 8. CONFIDENTIALITY

- i. In connection with this MoU, each party may disclose, or each of the parties may learn of or have access to, certain confidential proprietary information owned by the other party or its affiliates, business partners or clients ("**Confidential Information**"). Confidential Information is any information relating to the disclosing Party that is not accessible by the general public and includes not only information disclosed by the Party, but also information developed or learned by the Party during the performance of the Services.
- ii. The Disclosing Party's Confidential Information is to be broadly defined and includes all information, which has or could have commercial value or other utility in the business that the other Party is or may be engaged in and the unauthorized disclosure of which could be detrimental to the interests of the disclosing Party, whether or not such information is identified by disclosing Party.
- iii. Confidential Information includes, but is not limited to, any and all information or details of this MoU; any details relating to other party, its business and other contacts, discoveries, developments, designs, improvements, inventions, formulas, software programs, processes, techniques, projects, workshop training, know-how, data, research techniques, customer and supplier lists, marketing, sales or other financial or business information, scripts, approaches to designs, alternate ideas, time, effort estimates, costs and resources to build them, final solution and/or service deliverables, the means or cost of implementing,

production, mass-production, the component-usage, block diagrams, improvement-recommendations, part-lists, simulation results, testing methods, iterations made in order to achieve the final product. Confidential Information also includes information relating to other party, which is in the disclosing Party's possession under an obligation of confidential treatment.

## 9. INDEMNIFICATION

Each Party shall indemnify, defend and hold the other Party, its employees, representatives and agents harmless against any and all losses, liabilities, claims, damages, demands, costs and expenses (including legal fees and disbursements in connection therewith and interest chargeable thereon) asserted against or incurred by it that arise out of, result from, or may be payable by virtue of, any breach or non-performance of any representation, warranty, covenant or agreement made or obligation to be performed by the Party causing such breach or non-performance. Such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, or otherwise.

## 10. TERMINATION

- a. Unless otherwise provided, this MoU may be terminated by either party by giving prior written notice of at least 30 days provided that:
  - i. The other party has breached the terms of this agreement and that such breach cannot be rectified, within a period of 14 days post being served the notice for termination by the other party;
  - ii. The other party is involved in any illegal activity, wherein he/she acknowledges such guilt or is held by a competent authority to be guilty.
  - iii. The other party is subject to bankruptcy, liquidation, winding up, receivership etc. filed either voluntarily or by a secured creditor; or is otherwise subject to the appointment of an official liquidator, or by a competent court or tribunal or enters into any scheme or arrangement with creditors for the purpose of reconstruction, rescheduling or rehabilitation of its debts due to

financial distress or admits in writing its inability to pay its debts as they become due; or

- b. Either Party may terminate this MoU for cause by providing the other Party written notice if the other Party:
- (i) is in material breach of this MoU and has failed to rectify such breach within 30 days after its receipt of written notice of such breach provided by the non-breaching Party;
  - (ii) engages in any unlawful business practice related to that Party's performance under the MoU; or
  - (iii) Files a petition for bankruptcy, becomes insolvent, acknowledges its insolvency in any manner, makes an assignment for the benefit of its creditors, or has a receiver, trustee or similar party appointed for its property.
- c. The Parties may terminate the agreement on providing a 30 days' notice period to the First Party.

#### **11. WAIVERS, MODIFICATIONS AND AMENDMENT**

- a. The waiver of a breach of this MoU or the failure of a Party to exercise any right under this MoU shall in no event constitute a waiver as to any other breach, whether similar or dissimilar in nature, or prevent the exercise of any right under this MoU.
- b. This MoU may be amended / modified with the mutual consent of both Parties, by executing a fresh MoU containing such amendments / modifications, or by one Party communicating the need for an amendment / modification in writing, and the other Party accepting the said proposal and communicating its consent to the same in writing.

#### **12. SEVERABILITY**

Each provision of this MoU shall be interpreted in such a manner as to be effective and valid under applicable law. The invalidity or unenforceability of any provision of this MoU shall in no way affect the validity or enforceability of any other provision hereof. Any invalid or unenforceable provision shall be deemed severed from this

MoU and the balance of this MoU shall be construed and enforced as if this MoU did not contain the particular provisions(s) held to be invalid or unenforceable.

### **13. FORCE MAJURE**

The Vendor acknowledges that in situations where there is a delay or failure to perform obligations as per these terms, due to Force Majeure events including but not limited to acts of war, acts of God, earthquake, riot, fire, festive activities sabotage, labour shortage or dispute, internet interruption, technical failure, breakage of sea cable, hacking, piracy, cheating, illegal or unauthorized, neither the First Party nor the application can be held liable for any damages.

### **14. COSTS**

Each Party shall bear the respective costs of carrying out the obligations under this MoU. And also if the Parties may also share the expenses mutually between them, with a prior written consent from the respective Party should be obtained.

### **15. ASSIGNMENT**

Neither party shall assign any rights, duties or obligations under this MoU to any other party, without the written prior permission of the other party.

### **16. EXECUTION AND COUNTERPARTS**

This MoU may be executed (including by facsimile or internet-based service) by one or more of the Parties on any number of separate counterparts. All of such counterparts taken together shall be deemed to constitute one and the same instrument, and (if by facsimile) each such facsimile shall have the same force and effect as if an original.

### **17. DISPUTE RESOLUTION**

The Parties agree to first mediate any disputes or claims between them in good faith and resolve the disputes amicably and share the cost of mediation equally. In the event that mediation fails, any controversy or claim arising out of or relating to this MoU or breach of any duties hereunder shall be settled by Arbitration in accordance with the Indian Arbitration and Conciliation ACT, 1996. All hearings will be held at Chennai and shall be conducted in English. The parties shall each appoint an

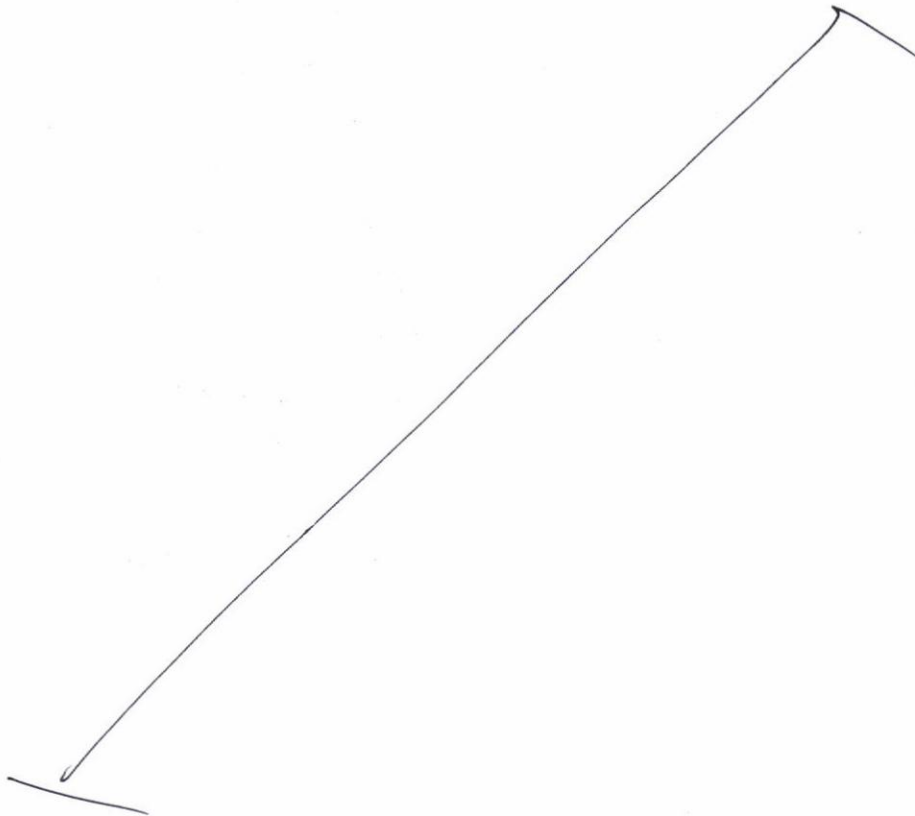

arbitrator who shall then appoint a sole arbitrator to preside over the Arbitration proceedings, and the award passed by such sole arbitrator will be valid and binding on both Parties.

**18. GOVERNING LAW AND JURISDICTION**

This MoU shall be governed by and construed in accordance with the laws of India only. Each party hereby irrevocably submits to the exclusive jurisdiction of the courts of Chennai for the adjudication of any dispute hereunder or in connection herewith or with any transaction contemplated hereby, and hereby irrevocably waives, and agrees not to assert in any suit, action or proceeding, any claim that it is not personally subject to the jurisdiction of any such court, that such suit, action or proceeding is brought in an inconvenient forum, or that the venue of such suit, action or proceeding is improper.
